SECTION 3 - HAZARDS IDENTIFICATION

Potential Acute Health Effects:

Hazardous in case of skin contact (irritant), of eye contact (irritant). Slightly hazardous in case of skin contact (corrosive,permeator), of ingestion, of inhalation. Severe over-exposure can result in death.
